GENERAL REQUIREMENTS FOR BUILDING PERMIT APPLICATIONS

- 1. A recent copy of the **State of Title Certificate** and copies of all easements, rights of way and covenants.
- 2. It is recommended you speak to a Planner before beginning your project.
- 3. The building permit application must:
 - (a) Be signed by the owner and if applicable owner's agent.
 - (b) Include details of the description of work.
- 4. The building permit application must include **2 printed copies and if possible 1 digital copy** of the specifications and scale drawings of the proposed construction showing:
 - (a) The dimensions of the building.
 - (b) The proposed use of each room or floor area.
 - (c) All brace wall band and brace wall panel locations as per 9.23.13 of 2018 BCBC.
 - (d) The dimensions of the land on which the building will be situated.
 - (e) Site plan showing setbacks to proposed and existing buildings with access routes.
 - (f) Mechanical ventilation design by qualified contractor.
 - (g) Riparian Areas Regulations Declaration.
- 5. The building permit application may also require the following:
 - (a) Preliminary truss layout from the manufacturer with all point loads shown and factored.
 - (b) Preliminary beam and floor joist layout if engineered products are proposed with **factored** loads.
 - (c) Hazardous Material Survey and Risk Assessment for buildings built prior to 1991.
- 6. The building permit application **MAY** require:
 - (a) Registration with Homeowner Protection Office (HPO) on NEW dwelling units:
